



REHEARSAL TRACK DUPLICATION AGREEMENT

This agreement is entered into between ClearCall Music ("ClearCall") and the church or organization indicated below ("Licensee"). Your signature will constitute an agreement between us with respect to a non-exclusive voluntary license under Section 114 of the United States Copyright Act for the duplication of cassettes or CDs, embodying the following musical compositions ("Compositions") listed below, for the choral book: AWAKEN THE DAWN Choral Collection.

(1) Hear, O Israel, (2) Come, People of the Risen King, (3) Creation Sings the Father's Song, (4) By Faith, (5) Compassion Hymn, (6) When Trials Come, (7) Benediction (May the Peace of God)

- 1. ClearCall is the copyright owner of the Sound Recording Master ("Master") of this musical/collection embodied in these Rehearsal Tracks, and hereby grants Licensee the right to duplicate the Master for the purposes expressed herein, subject to Licensee's completion of the provisions herein.
2. On behalf of the owner of the copyrights listed above, ClearCall hereby authorizes Licensee to duplicate from the Master only the Compositions listed above on CD or cassette for exclusive use by member of Licensee's performing group, specifically for the purpose of group or individual rehearsal. Licensee agrees to pay to ClearCall at the time of manufacturing, and ClearCall agrees to promptly forward to the owners of the copyrights, all mechanical royalties due for the mechanical reproduction made by Licensee. These rights are not transferable to any other party under any circumstances whatsoever.
3. Licensee is authorized to duplicate as many copies as is needed, provided you comply fully with these provisions, and pay the full amount due as calculated below.
4. The copyright notice which appears on the Master must be reproduced on every copy made by Licensee. This agreement does not grant or imply the right to duplicate other ClearCall masters or Compositions owned by the copyright owners.
